### 1. Land acknowledgement

Heather Buzila called the meeting to order at 3:32 p.m. and welcomed participants.

### 3. Parliamentarian

The Parliamentarian was Gael Spivak. President Heather Buzila told the meeting that Editors Canada uses *Robert's Rules of Order* for the annual general meeting, and the Editors Canada *Rules of Order Guide*. That guide says that meetings are to be conducted according to *Robert's Rules of Order*, and that other procedures and guidelines may come into play at the AGM.

Breanne noted there are a couple of typos that will be corrected for the final version (date change/year, 8 twigs instead of 9).

The treasurer Breanne MacDonald reported on the financial situation. Overall, we had a good year resulting in a surplus.

All of the branches have moved their bookkeeping to Young and Associates, having everyone use the same reporting structure made the audit go very smoothly. Conference was moved to a virtual conference due to the pandemic and it was very successful, especially following the cancelled conference in 2020. We had over 300 registrations which is a really good year for us. Helped to boost our revenue for the year. Membership numbers were up a bit as well.

Received a Canadian heritage grant which allowed us to hire a contractor to help us build up our French webinar program last year. We continue to receive other grants to help maintain office space and staff salaries. Our reserves were depleted after a few years of being behind, so a good year means that we can build up our reserves and plan for a hybrid conference event for 2023.

Our biggest source of revenue continues to be membership, followed by conference and webinars which all did well last year. Expenses were also up from 2020 but that's because there were no conference expenses in 2020. Our biggest expense is staffing, which is normal and other expenses are as expected. Many expenses are down because we are holding virtual events rather than in person during the pandemic.

Question: What do professional fees cover? Cover things like our auditor, bookkeeping, any service that wouldn't be handled by staff.





NOTE: Some of these motions have already been moved and seconded, this is allowed by Robert's Rules of Order as long as the motion has previously been distributed in writing, Section 4.15F. For motions 5, 6 and 7, these motions are being made because the National Executive Council of Editors Canada inadvertently voted on issues that had previously been voted on by members when instead the issues should have gone back to members for voting. Gail Spivak discovered these errors when compiling the decision log of all decisions made at past AGMs.

Carried. 84% In favour

Question: What is the background for this decision? There was a survey done by the francophone affairs director with all francophone members. The results of this survey showed that the francophone membership supported this initiative.

Question: Was it a paid position? No, the only positions that are paid are staff positions. This is a volunteer position.

Question: Was it voted on by members? It should have been voted on by members but was not. That's why we are voting now. The members voted to create the position initially, so the error was that only the NEC voted on changing the position.

Question: Why is this not a voting position? Because it's not a director position or national position, national positions don't vote on the NEC. Francophone advisor position would be better able to bring the issues to the NEC while still being close to the francophone membership. Was brought to the NEC by the francophone membership. Concerned about the way the messaging to francophone members was always coming from one person, creating silos. Lack of exposure to the rest of the organization. All committees and positions should be concerned with francophone affairs. Difficulty recruiting for a committee/director, all of the work on the NEC happens in English, it's tiring working primarily in English for those individuals. Champion the idea of a counsellor that everyone can go to, but that doesn't have an overwhelming amount of responsibility. Then the translation and editing group was created to increase the bilingualism of the entire organization.

Question: Why is it being dissolved? Saskatchewan has struggled to have the required number of members and executive positions. Right now, the required number of members to be a branch is

30 and there are only 20 members presently. They have struggled for 2 years to reach the minimum. They've also struggled to fill the executive positions. In 2020, they were given one year to form full executive and managed to recruit 6 but haven't been able to increase the membership and are now unable to find the minimum of 4 volunteers to step into the executive.

Question: Have they considered becoming a twig? They have not requested to become a twig. The members will have the opportunity to transition their membership to another branch or twig.

Call for nominations was communicated to the membership, and the committee contacted 34 candidates.
